Ladies and Gentlemen:

We have acted as special counsel to Rackspace Technology, Inc., a Delaware corporation (the “Company”), in connection with the Registration Statement on Form S-8 (the “Registration Statement”) of the Company, filed with the Securities and Exchange Commission pursuant to the Securities Act of 1933, as amended (the “Act”), and the rules and regulations thereunder (the “Rules”). You have asked us to furnish our opinion as to the legality of the securities being registered under the Registration Statement. The Registration Statement relates to the registration under the Act of an additional 20,000,000 shares of common stock, par value \$0.01 per share, of the Company (collectively, the “Shares”), that are reserved for issuance under the Rackspace Technology, Inc. 2020 Equity Incentive Plan (the “2020 Incentive Plan”).
